



TOWN OF CARMAN
BY-LAW NO. 22/2059

**BEING a By-law of the Town of Carman to establish
sewer and water rates including a pass through rate increase from
Pembina Valley Water Cooperative.**

WHEREAS the Town of Carman owns and operates a sewer and water facility within the limits of the said Town of Carman;

AND WHEREAS the Town of Carman purchases its water entirely from Pembina Valley Water Cooperative effective 2021;

AND WHEREAS the Pembina Valley Water Cooperative has approval from the Public Utilities Board for an increase of from \$9.34 to \$9.53 per 1,000 gallons in 2022 and from \$9.53 to \$10.10 in 2023, amounting to an increase of \$0.76 per 1,000 gallons;

AND WHEREAS The Public Utilities Board is permitting Cooperative member municipalities to “pass through” this rate increase to its customers;

NOW THEREFORE be it and it is hereby passed and enacted as a by-law of the Town of Carman, in Council duly assembled, as follows:

1. **THAT** Schedule “A” of the Water Rate By-Law No. 15/2005 and Pass-Through By-laws 17/2017, 18/2027, 19/2034, and 20/2047 be amended to include the approved water rate increase in 2022 and 2023 to Pembina Valley Water Cooperative, in the amount of \$0.76 per 1,000 gallons.
2. **THAT** this By-law shall come into force and become effective upon receiving third and final reading thereof.

PASSED AND ENACTED by the Town of Carman, in Council duly assembled, this 8th day of December 2022.
